1. In order to be eligible for the free VPS subscription you must:
 - a. be an existing or a new client of ETX Capital with a fully authorised ETX MT4 or TraderPro trading account (account opening is subject to compliance approval);
 - b. make a deposit of minimum £€\$2,000 in the base currency of your account; and
 - c. generate a minimum trading volume of five (5) lots of closed trades or £50 per point per month. Equity positions will be excluded for the purposes of calculating the aforementioned minimum trading volume.
2. Upon fulfilment of the abovementioned criteria, you must submit a request for the free VPS subscription via email to customerservice@etxcapital.com within ten (10) business days.
3. In the event of not satisfying the abovementioned criteria of generating the monthly required trading volume under clause 1c above, you will be charged with a fee of £25 or equivalent currency depending on the base currency of your account for the VPS subscription for each month where the requirement under clause 1c above has not been satisfied. The fee will be deducted from your trading account.
4. You can terminate the VPS subscription at any time by contacting the customer service team at customerservice@etxcapital.com. Once the VPS subscription is terminated, the VPS is cancelled without any backup, so you are solely responsible for taking any data backups prior to termination.

We reserve the right to cancel/remove this subscription at any time in case of any suspected abuse of the subscription. Further, where any term of this subscription is breached or there is any reasonable suspicion that a customer has acted fraudulently or obtained an unfair or unintended advantage, we reserve the right to terminate the subscription.
